Welcome and Prayer

GSC Interim Appointment

Eddy Aleman, general secretary, introduced Tony Schmid as the GSC's Chief Financial Officer. The GSC needs to appoint him as interim treasurer of the General Synod until the General Synod meets in June to vote to appoint him as its treasurer.

GSC 24-55 A motion was made, supported, and adopted:

To appoint Tony Schmid as interim treasurer of the General Synod of the Reformed Church in America.

The moderator thanked Lisa Stover for serving as interim treasurer since August 2023.

Commission Review Report

Judy Nelson provided a report on the annual GSC connection with the Commission on History.

Racial and Ethnic Councils

The NAIM Council has been working on developing its bylaws since the GSC approved formation of an interim leadership team to do so last March (GSC 23-32). Following GSC's action at its spring 2024 meeting to return the proposed bylaws to NAIM to consider several possible changes (GSC 24-40), NAIM adopted further changes to its bylaws at its annual gathering in late April, and presented the revised bylaws.

GSC 24-56 A motion was made, supported, and adopted:

To approve the bylaws of the Native American Indigenous Ministries Council; and further,

To formally reconstitute the council as an official racial and ethnic council of the General Synod Council of the Reformed Church in America, with all the rights and responsibilities thereof as indicated in the Book of Church Order.

The GSC reviewed recommendations from a GSC subcommittee that considered the report presented by the AABC regarding extra-*BCO* recommendations. The GSC subcommittee, composed of Nancy Boote, Vivian Campbell, Kimberly Van Es, and Maudelin Willock, processed this report and made two recommendations to the GSC in response.

GSC 24-57 A motion was made and adopted:

To ask the general secretary to find ways to 1) share the learnings from NBTS with the denomination (e.g., add ways to access this information to the Dismantling Racism webpage, prepare an article about the power and privilege work at NBTS); and 2) recommend concrete ways to systemically incorporate these learnings into the rhythms of the staff and denomination. We ask that the general secretary report on these efforts at the Fall 2024 GSC meeting.

GSC 24-58 A motion was made and adopted:

To ask the general secretary to research the possibility of creating a diverse volunteer team with representatives from each racial-ethnic council who would be trained with a racial equity lens. We ask that the general secretary bring a detailed related recommendation to the Spring 2025 GSC meeting; this recommendation should consider whether the GSC should propose to the General Synod that money set aside for General Synod special initiatives should be applied toward these efforts.

Executive Session

The GSC met in executive session, during which the Relationship and Review Committee gave its report.
