# GENERAL SYNOD REFORMED CHURCH IN AMERICA

# 2024 Journal of Actions Meeting 9 Sunday evening - June 16, 2024 Arizona Ballroom

### CALL TO ORDER

The president called to order the ninth meeting of the General Synod at 7:01 p.m. on Sunday, June 16, 2024. The Rev. Richard (Garret) Szantner, regular delegate from the Classis of Schenectady, offered prayer.

### **VIDEO**

Delegates viewed a brief video from the Rev. Dr. David Kahler, who also serves as an active duty Chaplain Lieutenant Colonel in the Air National Guard, regarding his bi-vocational discernment process.

### REPORT OF THE GENERAL SYNOD COUNCIL ON ADVANCEMENT

The president called upon Larryl Humme, Director of Advancement, to present the Office of Advancement report (GS Workbook pp. 62-63). Mr. Humme addressed the Synod. His presentation included a description of the Van Bunschooten Bequest. The Synod expressed its appreciation for a recent gift from the Ralph Guarno Living Trust for the benefit of The Reformed Church in America Church Growth Fund, Inc.
